Order

WHEREAS, the recognition was granted to the institution, namely, MAHARASHTRA COSMOPOLITAN EDUCATION SOCIETY, 2390, K.B. HIDAYATULLAH ROAD, AZAM CAMPUS, PUNE CAMP, PUNE-411001, MAHARASHTRA for B.Ed. (Integrated) course vide order No. WRC/5-6/89/2006/C-11856 dated 05.03.2007 for an annual intake of 50 seats.

2. AND WHEREAS, the matter was placed in the 309<sup>th</sup> Meeting of WRC held on July 23-26, 2019 and the Committee has decided the following:-

*"The recognition was granted to the institution vide order No. WRC/5-6/89/2006/c-11856 dated 5/03/2007 for B.Ed. integrated intake 50 Students. The programme B.Ed. integrated be read as B.A.B.Ed. integrated. Corrigendum may be issued accordingly."*

Corrigendum was issued to the institution on 01.07.2019.

3. AND WHEREAS, the institution vide letter dated 24.01.2023 received in WRC on 10.02.2023 has submitted about information establishment of University and requested for grant of permission for change of Affiliating University/Examining Body of the following College/institutions from University of Pune to Dr. P.A. Inamdar University and have now become constituent colleges/institutions of Dr. P.A. Inamdar University.

4. AND WHEREAS, the matter was placed in the 387<sup>th</sup> Meeting of WRC held on 09<sup>th</sup> & 10<sup>th</sup> June, 2023 and committee decided that the change of affiliating body be permitted in respect of following institutions under the same society recognized by WRC NCTE from "University of Pune" to it newly established University viz. "Dr. P.A. Inamdar University, Pune."

5. AND WHEREAS, the matter was placed in the 392<sup>nd</sup> Meeting held on 22<sup>nd</sup> August, 2023 and the Committee has decided that Show Cause Notice issued to the institution on 05.09.2023 and stating that private university cannot grant affiliation to the institution. In response of institution has submitted compliance of the show cause notice letter dated 20.10.2023 in WRC on dated 01.11.2023.

6. AND WHEREAS, the matter was placed in the 402<sup>nd</sup> Meeting held on 27<sup>th</sup> march and the Committee has decided that the institution be asked to submit certified registered land documents with address and location related to conduct of different teacher education courses (present and proposed). The institution shall submit the requisite documents within 15 days from the date of issuance of communication from WRC, NCTE.

Accordingly, the letter was issued to the institution on 12.04.2024. In response of the institution has submitted its reply vide letter No. Dr.PAIU/REG/NCTE/2023-24/188 dated 08.04.2024 received in WRC office on 16.04.2024.

7. **AND WHEREAS**, the matter was placed in its 408<sup>th</sup> (Part-1) Meeting of WRC held on 12<sup>th</sup> – 14<sup>th</sup> November, 2024 and the Committee decided that the institution be sought aforementioned clarifications to submit reply along with requisite documents and affidavit within 21 days from the date of issuance of letter. Accordingly, a letter was issued to the institution on 17.12.2024. In response of the institution vide letter dated 23.12.2024 received in WRC on 01.01.2025 has submitted reply as clarification to the issue raised in the minutes of the 408<sup>th</sup> Meeting (Part-1) of WRC-NCTE.

8. **AND WHEREAS**, the matter was considered in its 413<sup>th</sup> Meeting of WRC held on 27<sup>th</sup> – 29<sup>th</sup> January, 2025 and the Committee decided that the following:-

*"The matter was placed in its 408<sup>th</sup> Meeting of WRC held on 12<sup>th</sup> – 14<sup>th</sup> November, 2024 and the Committee decided that the following:-*

*The Committee considered request of the institution for change of affiliating body in respect of the following institutions under the same society recognized by WRC NCTE from "University of Pune" to its newly established University viz. "Dr. P.A. Inamdar University, Pune.*


